I. INTRODUCTION

"Let there be no day in your life in which you did no good to others." - St. Chavara

Being a remote area with a high concentration of population of tribal community, basic rights related to health and other areas are neglected or denied. Basic facilities related to health are not available for the general population. As 85% people belonging to the scheduled tribes and castes, they are all the more not able to avail the services due to various reasons.

Sanjeevani Service Society has been working in Block of Chhindwara through Community Based Rehabilitation for the Empowerment of Persons with Disability since 2010. It aims strengthen programme for the children with disabilities through Community based rehabilitation and associated institutional care for the empowerment of persons with disabilities especially for the children with disabilities in various ways such as awareness generation, early identification, diagnosis – treatment, income generation and advocacy. Now we wish to strengthen our existing programme and methods through an organized centre for rehabilitation through therapeutic and skill development

facilitation at Block Head Quarter at Harrai. This centre would be benefited by persons with disabilities especially children and youth with disabilities and persons with serious illness. Our special target group would be children and youth.

Taking into consideration all the factors related to this reality, Sanjeevani Service Society has purchased a plot of land where a centre could be developed which would work for the children of this area who suffer from disabilities, malnourishment, paediatric diseases, etc.,.

The proposed project was for the construction of a center where facilitation of programme for the persons with disabilities will be undertaken, skill development programme will be conducted and a central facilitation center for the CBR Physiotherapy programme will be held.

The entire project will be undertaken with the support of various individuals, agencies and institutions. Some of benefactors of this noble endeavour are Foundaiton for the Poor, Fr. Pauly Thekken, CMI Seva Sangh.

II. Final Design for the building

In consultation with the experts and our collaborators, we prepared a plan for proposed institution. The proposed institutions have Four class rooms, one physiotherapy centre, an office cum facilitation centre and few accommodation facilities. A detailed plan was submitted to the municipal plan committee and was sanctioned. All the taxes and other payments are done. A detailed engineer plan is given to the contractor, Mr. Ajay Agrawal who will construct the building as per the designs and direction of Our Engineer, Fr. Raphel Parambath and us.

We have finalized the final plan for the construction of the building with 9 nine rooms. Out of these nine, One room will be a Church cum prayer room, one Office, two Class rooms, one Physiotherapy room and other rooms will be utilized for residential and other purposes. Please find the final plan as attached.

IV. Activities undertaken

1. **Finalization of Design and Contractor:** We have finalized the design for the building. It is a single story building with 9 rooms, designed for prayer room, office, physiotherapy, class rooms and accommodation etc. We have sufficient frontage and space behind the building.


We have also finalized with the contractor of the building. Mr. Ajay Kumar Agrawal who has undertaken some of our other buildings is given the contract of constructing the building before May, 2022.

- 2. **Digging for Foundation:** As per the design of the engineer, digging for the foundation is completed. As the land is very hard, there is no need of digging too deep. Almost all the pits are 2- 3 feet deep.
- 3. Store Room construction: A small room for the storage of cement is being constructed. This is done by the contractors at their own expense for safeguarding their building materials and others equipments. Some of the labourers also would stay there.
- 4. **Temporary Motor shed:** a temporary motor shed is made for using water while construction is on. The permanent connection will be given only after the construction of the building. Electricity connection taken for Motor and Construction
- 5. **Tube well is dug and motor is installed:** We have dug a tube well for the center and a motor is installed recently. The well is 730 feet deep. We have installed the motor at 500 feet. Hope we will have constant and good water available through out the seasons.


V. Phases of Construction planed

VI. Funding for the Programme

We have planned the project with the support of the following individuals and agencies

- 1. Foundation for the Poor
- 2. Fr. Pauly Thekken
- 3. CMI Province, Bhopal

The plan got started with assurance of Fr. Pauly Thekken. He realizing the fact that even after 6 years we are not able to construct the building for the service of persons with disabilities and drop out youth, promised his support for the construction of the building partly.

Mean while Foundation for the Poor has come up with sponsoring the cost of Two class rooms and Physiotherapy center, which came as great relief. Foundation for the Poor in turn in collaboration with Loyola Foundation is supporting this effort. We are hopeful of continued support for this programme of ours from Foundation for the Poor. We will be building Three rooms with the support of Foundation for the Poor. One room will be used for the Physiotherapy center which will be used persons with disabilities from the remote villages. Other two rooms will be used as the class rooms for drop out students or skill development for the youth of scheduled tribes or scheduled castes and others. The proposed area for this two rooms are 21 feet x 36 feet (a total of 756 feet.) and a veranda of 200 feet.

CMI Province, Bhopal which is the society of our fathers working in Madhya Pradesh is always with us to support where need comes and has agreed to support in need.

VII. Project for the year 2023

We would like to propose a new proposal for the year 2023 in continuation of this present project at Harrai. We are hopeful of completing this project by the end of May, 2023 with completion of the construction the building. In order to use this building for the purpose which we intent, we will have to have sufficient equipments, furniture and professionals to use them.

We would be greatly obliged to Foundation for the Poor if you can support us in furnishing the centre with furniture and equipments for three specific things and support for a Coordinator of the Programme at the Center who will coordinate the programme at village in consultation with Father in Charge and a part time physiotherapist for the center.
